Membership entitles the holder to unlimited greens fees at Paschal Golf Club, Inc. Cart rental fees are not included and are paid at time of rental. Members elect the board of directors at the annual members meeting.

Membership Definitions

<u>Single membership</u> - is defined as any individual eighteen years or age or older.

<u>Couple /Joint membership</u> - is defined as two individuals that are members of the same household, regardless of age.

<u>Family membership</u> - is defined as three or more members of the same household, so long as the child(ren) are under eighteen years or age.

Student membership - is defined as any individual twelve to seventeen years or age.

<u>Grandchild membership</u> - is defined as one twelve to eighteen year old grandchild of a member in good standing.

Payments

All <u>NEW MEMBERS</u> Initiation fees are waived. A quarterly payment is due with the new members' application and will be prorated for the quarter in which application is received.

Dues are an annual amount and become due January 1, however members are allowed to make quarterly payments. Quarterly payments are due; January 1, April 1, July 1, and October 1, of each year. Any member that is 15 days past due on their quarterly payment will be charged regular greens fees until their account is current.

Annual dues for student or grandchild memberships are due at time of application and one year hence each subsequent year until the age of ineligibility.

If any membership payment is 40 days past due, membership will be automatically terminated. If a membership account is terminated automatically, or voluntarily, the member will be expected to pay the initiation fees should they wish to open a new membership account.

The Board of Directors will cooperate with members that encounter medical issues that cause them to put their memberships on hold during recuperation. The member is responsible to keep the Board updated on their recuperation; otherwise it will be assumed the member has voluntarily resigned. **Voting Privileges**. Members eighteen years of age or older, in good standing that have no outstanding balance due, are entitled to one vote at the annual members meeting.
